Instructions

The Collector Vehicle Program offers special insurance coverage to customers who own collector vehicles. To be eligible, your vehicle must meet certain criteria (see **Declaration**) and you must qualify your vehicle.

You must complete and sign both copies of this form (Applicant Copy and Qualifier Copy) and take both to your qualification appointment. Once you have qualified, you must visit an Autopac agent in person and present the completed and stamped Applicant Copy for processing.

All qualified customers receive a unique collector vehicle licence plate. Personalized plates are also available. To request a personalized collector vehicle plate or to transfer an existing personalized message to a collector vehicle plate, please complete and submit a **Collector Vehicle Licence Plate Application** form.
